GUIDE TO EDITOR'S NOTES IN LETTERS: These 8 letters are numbered after the letter writer's names.Handwritten words are in plane type. Paragraphing and punctuation are added by editor to make the meaning clear. *Italics are used to insert information in the text of a letter, such as "(sic)" for errors of writer not corrected, or an explanation of who a person is, or a full name.* **Bold type is used to select from the text a name or idea the editor thought important.** " ?" means editor is unsure of word (s) meaning. A "*" means editor made copy of letter.
